Abstract:

The failure to take into consideration gender inequalities and the under-representation of women in decision bodies have been identified as important brakes in terms of social change. To understand better that problem, we would like to investigate what are the consequences of ongoing political transformations concerning local democracy.

This paper is based mainly on a comparative case study conducted from 2000 to 2003 in seven European countries (Belgium, France, Finland, Greece, Italy, Portugal and Sweden) going form the North to the South of Western Europe. It concerned some eighty towns where the percentage of women within elected bodies happened to be quite different at that time and covered some 600 interviews. The objective of the research was to evaluate the effects of the gendered composition of elected political bodies on the functioning of local institutions and to explore women's dynamic contribution to the fate of local communities. At the heart of the analysis was as well the interaction between political bodies and civil society.

The outcomes of the investigation have shed light on the dynamic of changes within municipal councils. Indeed the presence of women in local government led to innovative public policies in several cases, and examples of countries such as Finland, Italy, and France demonstrated that changes in forms of governance influence women's capacity to develop innovative policies. But this went hand in hand with a trend observed in several countries concerning the regression of the real power of the councils, particularly in the economical field (the changing locus of decision-making from town councils to inter-communal structures are processes which throw women's increasing power in local government back into question). Anyhow, in all the considered countries, one could observe that the feminization of these bodies is not sufficient *per se* to insure that that the gender dimension is seriously treated within the local life. Not only do the political configurations weight on the proclaimed objectives, but the plans of action and *material means* linked to the gender policies of equal opportunities appear to be decisive in the evaluation of high-ranking administrative positions and with closed links with feminist groups or movement, they often appear to become a dead letter.
