The CEFC has recently obtained funding for two new collaborative research projects

1) **Projet FINURBASIE** Funding : ANR Hosted by: CEFC and Laboratoire Techniques, Territoires et Sociétés (LATTS, CNRS - Ecole nationale des Ponts et chaussées - Université Paris Est) Duration : 2013-2015 Principle investigators: Natacha Aveline (CNRS), Ludovic Halbert (LATTS).

FINURBASIE is a research project jointly developed by the French Centre for Research on Contemporary China (CEFC) and the Laboratory Techniques, Territories and Societies (LATTS). It is concerned with the financialization of urban production processes in China and India. It sets out to explore, in two highly populated and fast-urbanizing countries, the multifarious forms taken by the circulation of finance capital in the real estate sector, and their effects on the production of the urban built environment. The project takes issue first with the role of property markets in economies that are increasingly interconnected and affected by recurrent global financial crises. It also questions the ways in which urban development in large-scale "emerging" countries is financed. Going past often a-spatial approaches, the project will analyze the specific geographies associated to the growing amount of finance capital invested in the urban built environment. It will discuss both its geographic diffusion and the resulting territorial differentiation processes.

2) **New Approaches to the Mao Era (1949-1976): Everyday History and Unofficial**

Much of the research published on the Mao era – the early 1950s, the Anti-Rightist movement, the Great Leap Forward and the famine, the Cultural Revolution – relies overly on Party sources and various types of internal but nonetheless official publications. Archives are difficult to access and first-hand accounts

are often skewed, providing little information about the everyday lives of ordinary people. In recent years, there has been a slight opening of archival sources, and in parallel, a significant development of oral history projects in China, as the generations of first-hand witnesses of Maoism reach old age. They open a fruitful realm for new research, both on everyday society under Maoism as a historiographical object and on the way Maoism is remembered by ordinary people. These two components – the documentation of history and the preservation of memory – are inseparable in the emergence of a critical history of Maoism. We propose to investigate various aspects of this field, ranging from new archives and oral histories of everyday life under Mao, in particular the violence that characterized social relations at the time, to the contemporary efforts devoted to preserving a non-official memory of Maoism. These efforts call into question the Party's monopoly on writing the history of the People's Republic. While some of the "memorial" activities developed by former Rightists or Educated Youths are nostalgic and generally uncritical, many other forms of association and sociability are based on the desire to critically confront the past, using the tools of research and historiography, in order to build a "popular" or "unofficial" (minjian) history of post-1949 China.

The Reform of the Reeducation through Labor (lao jiao) System

Prof. Fu Hualing (University of Hong Kong) Dr Nicholas Bequelin (Human Rights Watch) Joshua Rosenzweig (Chinese University of Hong Kong)

While reform of the Re-education through labor (RTL) system has been on China's legislative agenda for a number of years, the sudden announcement last January that the Party intends to dismantle the system by the end of the year has caught many by surprise. Indeed for decades the Public Security Bureau has successfully resisted attempts to reform a system that it considered necessary for the fulfillment of the missions mandated by the Party. So what has changed? And what comes next? The decision raises both practical issues--what to do with the people formerly "dealt with" through RTL (minor offenders, drug

users, prostitutes and dissidents)--as well as political one--what, in the eyes of the new leadership under Xi Jinping, should the law play in the governance of China? For more information, click [here](#).

All Those Years Ago: Rethinking the MacLehose Decade

Prof. Lui Tai-lok (University of Hong Kong)

The governorship of Lord Murray MacLehose (1971-1982) was always fondly remembered as a period of benign colonial rule, an era of progressive reforms (particularly the establishment of the Independent Commission Against Corruption), and a decade when the local Chinese community in Hong Kong espoused a new identity and developed a sense of belonging that was not found in the earlier decades. The tenure of his governorship was the longest among all governors since 1842. The so-called 'MacLehose era' has been seen as a turning point in the contemporary history of Hong Kong, marking the birth of an affluent society, the formation of local culture, and the building of a social system characterized by political stability and economic prosperity. This talk is an attempt to look at Hong Kong society in the 1970s, and the colonial rule under MacLehose, from a different perspective. The speaker calls for a re-examination of the coloniality of Hong Kong.

Looking at China: the Third Way

Prof. Wu Jieh-min (Institute of Sociology, Academia Sinica)

What is called the "China factor" in Taiwan strews a global anxiety. It is particularly hot in the margins of the new empire as can be seen in the mobilization of Taiwanese students against the buyout of Apple Daily by media "monster" Want Want China Times, the recent protests in Canton to encourage the journalists of Southern Weekly, last autumn demonstrations in Hong Kong against the promotion of Chinese patriotism at school. While the Taiwanese economy was supposed to benefit from free-trade agreement with China, the population of the island seems more and more concerned how to face China's hegemony. Wu Jieh-Min has observed the Chinese society for almost twenty years. His last opus 第三種中國想像 (A Third View of China, Taipei, Rive Gauche Publishing 左岸文化 2012/11) has already nourished passionate debates in Taiwan. The author introduces the complex reality of China today from a Taiwanese point of view but getting rid of pan-blue or pan-green' fantasies. He thus proposes another way of thinking the independence/reunification issue.

Fragments of an Unfinished Civil War

Taiwanese Entrepreneurs and the Partition of China Françoise Mengin

(Center for International Studies and Research at Sciences Po, Paris)

The Republic of China that retreated to Taiwan in 1949 has continued to maintain its de facto independence. Yet the Communist authorities have never abandoned their aim at reunifying the island with the PRC de jure. As well as growing military pressure, Beijing's irredentist policy is premised on encouraging cross-Straits economic integration. Responding to preferential measures, Taiwanese industrialists massively relocated their activities on the mainland. Fragments of a nation torn apart by contradictory claims, these entrepreneurs are vectors of a unification imposed by the Chinese Communist Party, promoted but postponed by the Kuomintang, rejected by Taiwanese pro-independence parties.
